Change Report "How and Why"



If change due to additions, subtractions, or estimator error (please indicate) Date Change to original estimate All change orders must have an approved amount prior to installation by estimator or office Amount Quoted and APPROVED by Homeowner/Contractor

To expedite the invoicing process, this can be one of the most important things you can fill out on a job. ANY AND ALL changes made, MUST be approved by homeowners or builders, and communicated with the Estimator and Office staff (See yellow stars above). Quotes will be provided to communicate the difference in cost to the homeowner/builder. If the amount of product installed does not match what was estimated, enter the reason here. If it looks like a mismeasure, reach out to the estimator to discuss. This section must be filled out in its entirety.


Do's & Don'ts



January 2021 Installer Average NET % and Company Goal




A net percentage of 45% is the target number for MGI jobs to maximize profitability. While the Net % (profitability) is often heavily influenced by the installers there are times that other outside factors have an impact on this number. This figure reflects the success of the company as a whole; from the call to set up an estimate to the final walk through with the foreman after the installation.
